CONSIDERATION OF APPROVING A RESOLUTION THAT WOULD PLACE A 1.26 MIL INCREASE ON ALL ESSEXVILLE APPLICABLE PROPERTIES FOR A PERIOD NOT TO EXCEED 5 YEARS FROM THE DATE OF ASSESSMENT FOR THE SOLE PURPOSE OF FUNDING THE PURCHASE OF A NEW FIRE TRUCK FOR THE FIRM PRICE OF 4,361.00 PLUS THE 2.37% COST OF FINANCING FOR A FINAL TOTAL COST OF \$445,567.00. RESOLVED; A public hearing having been held, the City Council hereby finds that the current city fire truck has become in an undependable condition and may not function properly in the event of a fire which constitutes an emergency existing whereby it is necessary to protect the public health, safety, and welfare of the city by adjustment of the current budget to allow for the purchase of another fire truck, and it is thereby further resolved as follows:

1. That the City Manager is authorized to enter into a five year loan agreement for the purchase of a 2018 Spartan S180 Model 2111 Fire Truck for a total delivered complete price for \$445,567.00 (Four hundred forty five thousand five hundred sixty seven dollars) with the exact terms of the installment contract to be determined, and

2. That the city budget passed by the City Council on June 13, 2017 is hereby amended to provide for additional funds to allow for the purchase of a vehicle to replace its current disabled fire truck by an installment payment contract to provide funds in the amount of \$89,113.00 dollars with which to make the first year's payment and to increase the millage taxed on the December 2017 tax billing to properties of the city be increased by 1.26 mills to provide funds for such payment."
