CONSIDERATION OF AUTHORIZING THE QUESTION OF A GENERAL CHARTER REVISION AND THE ELECTION OF A CHARTER COMMISSION TO BE SUBMITTED TO THE ELECTORS

Weiler. Tanner:

WHEREAS, section 5.11 of the Charter of the City of Essexville reads: "The question of a general Charter revision shall be submitted to the electors at least every tenth regular odd year City election after the effective date of this Charter."; and

WHEREAS, the effective date of the present City Charter is January 1, 1999; and

WHEREAS, Michigan law, specifically MCLA 117.18, provides for the general revision of a charter and the election of a charter commission; and

WHEREAS, Michigan law, specifically MCLA 117.19, requires the legislative body of a municipality, in advance of the election of a Charter Commission, to fix the place of its meeting, the compensation of its members, appropriate funds for the expenses of the Charter Commission, and if need be provide the ballots for election,

NOW, THEREFORE, BE IT RESOLVED, that the City Council in accordance with the requirements of Section 5.11 of the City Charter directs that the question of having a general charter revision be submitted to the electors of the City of Essexville for adoption or rejection at the general election to be held on the fifth day of November, 2019.

BE IT FURTHER RESOLVED, that said question on the general revision of the charter shall read "Shall there be a general revision of the charter of the City of Essexville?" Yes __ No __.

BE IT FURTHER RESOLVED, that pursuant to law and concurrent with the submission of the question of a general charter revision to electors of the City of Essexville there shall also be an election of a Charter Commission.

BE IT FURTHER RESOLVED, that the last day and hour for receiving nominating petitions for candidates for the Charter Commission shall be 4:00 p.m. on Tuesday, July 23, 2019.

BE IT FURTHER RESOLVED, that if the general charter revision is approved by the electors, the Charter Commission shall hold its meetings at the Essexville City Hall and each Charter Commissioner shall receive a per diem compensation of \$20.00 for each meeting attended up to a maximum compensation of \$1,800.00 per Charter Commissioner.

BE IT FURTHER RESOLVED, that if the general charter revision is approved by the electors, the fiscal year 2019/2020 budget shall include appropriate funds from the General Fund to pay the proper expenditures of the Charter Commission subject to the following:

- 1. The City Manager shall establish an activity within the General Fund to account for expenditures of the Charter Commission; and
- 2. The City Manager shall prepare a monthly written report detailing the expenses incurred by the Charter Commission; and
- 3. All expenditures of the Charter Commission shall be made pursuant to the City Charter and City Council policies.

BE IT FINALLY RESOLVED; the "Resolution Authorizing the Question of a General Charter Revision and the Election of a Charter Commission to be Submitted to the Electors" as prepared by the City Manager and submitted to the City Council for its consideration at the regular meeting of the City Council on May 14, 2019 is adopted.
